Promotion Overview

Every Friday between January 18 and February 22, 2019 at Club Regent Casino (CRC) and McPhillips Station Casino (MSC), Manitoba Liquor & Lotteries Corporation (MBLL) will be conducting a “Snowbird Getaway” Club Card scan to win promotion.

There is no purchase necessary to participate in this promotion.

Club Card members participating in this promotion must meet all eligibility requirements as stipulated in this Promotion Overview and Rules & Regulations.

Odds of being selected are dependent on the total number of valid Club Card scans received at all designated scanners at either CRC or MSC during the scan times listed in the draw matrix below.

To qualify, Club Card members must scan their active Club Card (rule #6) at any of the designated CRC / MSC Club Card scanners in accordance with the following draw matrix:

MBLL will randomly draw the names of six (6) Club Card Members at each casino, from all valid Club Card scans received at designated scanners at CRC or MSC, in accordance with the Snowbird Getaway draw matrix.

- Selected Club Card member(s) name will be posted at 9:15 pm and must claim their prize in person at the designated CRC / MSC promotions table within fifteen (15) minutes of their name being posted on the casino digital screens. If the selected winner does not claim within fifteen (15) minutes, they will forfeit their claim to the prize and an alternate will be selected. This process will continue until up to twelve (12) names (s) have been drawn. Should no one claim, a final alternate will be selected next business day and contacted (Rule # 7).
- Proxies will not be permitted.
- Winner(s) name will be posted throughout the casino on EDSN screens.

Available “Snowbird Getaway”* Prizes:

Each trip prize consists of:

Manitoba Liquor and Lotteries (MBLL), Transat Distribution Canada, (“**TDC**”) and Paradisus Properties by Melia (“**Melia Resorts**”) employees and their immediate family members are not eligible to participate in the “Snowbird Getaway” Club Card Scan to Win promotion. In the event a Manitoba Liquor & Lotteries, (“**TDC**”) and/or (“**Melia Resorts**”) employee and/or immediate family of an employee does participate any prizes won will be forfeited.
2. Club Card Members must be eighteen (18) years or older to participate.
3. Persons under voluntary or involuntary exclusion are not permitted in Club Regent Casino (CRC)/McPhillips Station Casino (MSC); and therefore, may not apply for or participate in the Club Card program for the duration of the exclusion.

6. Only active Club Cards are eligible to participate in this promotion. An active Club Card is defined as having recorded activity within the past eighteen (18) months.
